If you are under 18 years old and the child of STUST faculty, staff or students, your legal representative should read, understand and agree with all content of the consent form specified below:

一、蒐集個人資料之目的與類別(Purpose of collection and types of the personal information) 本館為執行圖書館相關業務,需蒐集您的個人資料包括姓名、證號、身分證字號、連絡電話 與地址、電子郵件地址等。

In order to process and administer library businesses, we have to collect your personal information including names, card numbers, identifying number, telephone numbers, home addresses, and e-mail addresses.

- 二、個人資料利用期間與範圍(Time period, scope and use of personal information)
 - 本館將於蒐集目的之存續期間或因執行業務所必須的保存期間內合理利用您的個人資料, 利用地區不限。
 - All information collected will be used appropriately within the scope of reasonable purposes and not go beyond the necessary time and purpose of collection.
 - 2、本館將利用您的個人資料以進行服務,及業務執行所必須之各項聯繫、通知與統計分析等。 The library will use personal information for services, relevant business contacts, notices and statistical analyses.
- 三、個人資料之提供(Providing personal information)

The information that you have disclosed to us will be handled responsibly . We will not disclose your personal information to any third parties or use for other purposes, except as permitted by law or with your consent.
